CONDITIONS OF BOARDING

NOTE *Cats will only be accepted to board if signed consent/acceptance is given for these conditions of boarding by the owner, or by a person authorised by the owner.*

To protect your cat from exposure to germs, viruses, fleas and worms the following are required prior to boarding.

- Cats must have proof of a current (within the last 12 months) vaccination certificate.
- Where the cat has been vaccinated in the previous 4 weeks, proof of the prior vaccination certificate must be provided to ensure the cat has adequate cover.
- Cats must be de-sexed if over 6 months old.
- Kittens under 12 months must have all their vaccinations up to date.
- Cats should be wormed at least every three months, but especially prior to boarding.
- Cats should be protected against fleas by using a monthly application of flea treatment such as Frontline, Advantage, Revolution or similar. (Collars are ineffective).
- Please note that if fleas or worms are identified on your cat, they will be treated at the cattery with an additional cost charged to the owner.
- Cats must be in good general health with no known infectious diseases.

If your cat appears unwell, or off colour prior to boarding please consult your vet. If your cat is clearly sick it will NOT be accepted for boarding.

1. I (the owner) agree that in cases of illness or injury, a Veterinary Surgeon will be consulted and as necessary any treatment he or she advises will be carried out. The consultation and treatment will form part of the total boarding fees.
2. I agree to pay, in full, all fees and charges incurred by the boarding of my cat(s) by the date boarding is completed. Such fees will be paid by cheque, cash or electronic funds transfer.
3. Where my cat will be in boarding for longer than 14 days, I agree to make good pre-payment of the first 14 days on request in advance to confirm the booking.
4. Where no notification is made of an extension to the boarding dates, or your cat(s) have not been collected after 14 days of the agreed boarding period, I give consent and authority for the Proprietor of the Cattery to take my cat(s) to the RSPCA, or the Animal Welfare League and for these organisations to place or dispose of my cat(s) at their discretion. I further agree to indemnify the Proprietors of the Cattery of any liability, costs or charges whatsoever in respect of their action and agree to pay all costs and charges in connection with such action.
5. I agree that there shall not be any liability or responsibility imposed on the proprietors in respect of any matter whatsoever in the event of my cat(s) dying, being injured or acquiring any illness during the period of boarding, providing reasonable care has been taken. I further agree to pay all costs and charges incurred in such events.
6. I understand that there are risks associated with my cat(s) mixing with other cats, including the possibility of disease and injury, and I have chosen to accept the consequences, should there be any.
7. I agree that the terms of this agreement shall be valid for any cat(s) I board, and for the initial and all subsequent boarding periods.

It is the responsibility of the owner to make known any injuries, existing conditions or illnesses, and/or food allergies.
